EXECUTIVE ORDER NO. 04
Series of 2020

AN ORDER SETTING THE DEADLINE FOR THE PAYMENT OF THE MONETARY OBLIGATIONS TO THE CITY GOVERNMENT PURSUANT TO ORDINANCE NO. 9 SERIES OF 2020

WHEREAS, the President of the Republic of the Philippines, Rodrigo Roa Duterte, through Proclamation No. 929 issued last 17 March 2020, declared a State of Calamity throughout the Philippines due to the spread of the Corona Virus Disease or COVID-19 in the country;

WHEREAS, on 20 March 2020, the Sangguniang Panlungsod of the City of Taguig passed an ordinance authorizing the City Mayor to extend and set the deadlines for the payment of the amounts due and payable to the City Government during the period of the enhanced quarantine, *provided, however*, that the extension of the date of payment of the local taxes, fees or charges earlier mentioned shall not be more than six (6) months.

NOW, THEREFORE, I, LINO S. CAYETANO, City Mayor of Taguig by virtue of the powers vested in me by law, do hereby order and declare:

SECTION 1. COVERAGE – This Order shall be applicable to the following financial obligations:

- a. Payment of local business taxes (second quarter, 2020) due on April 20, 2020;
- b. Payment of real property taxes (first quarter, 2020) due on March 31, 2020;
- c. Payment of transfer taxes and corresponding city taxes, if applicable, that will fall due within the period of the enhanced community quarantine or from March 17 to April 14, 2020;
- d. Payment of Amusement taxes due on April 20, 2020; and
- e. Other taxes and fees, that will fall due and payable to the Taguig City Government during the period of enhanced quarantine or from March 17 to April 14, 2020; and
- f. Rents, charges, or otherwise any financial obligation which may fall due and payable to the city government arising from law or contract.

SECTION 2. DEADLINE FOR THE PAYMENT OF MONETARY OBLIGATIONS TO THE CITY GOVERNMENT – The deadline for the payment of the above financial obligations in Section 1, is hereby extended to **MAY 20, 2020**.

Payment of the amounts due and payable to the City Government on or before the extended deadline shall not incur any relevant charges, penalties and interests.
