WHEREAS, the City Budget for Calendar Year 2020 is still pending review of the Department of Budget and Management (DBM);

WHEREAS, in order not to disrupt the operation of the City Government while said review of the 2020 Budget is underway, it is necessary that the City Government be authorized to spend part of the Calendar Year 2019 Budget in line with Section 323 of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991";

NOW, THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of the City of Taguig, in session duly assembled:

Section 1. The City Treasurer is hereby authorized to spend and/or disburse One Twelfth (1/12th) of Calendar Year 2019 Budget every month starting January 2020 in accordance with the provisions of Republic Act No. 7160 otherwise known as the "Local Government Code of 1991".

Section 2. The aforementioned authorization shall be effective only during the pendency of the review of Calendar Year 2020 Budget by the Department of Budget and Management (DBM) and shall automatically become inoperative upon approval by the said body. This Ordinance shall take effect January 02, 2020.
